

Privacy Statement

Related to the use and processing of personal details

NABC takes great care to treat the personal details of any person visiting NABC website careful. Personal details are processed and protected in conformity with the Dutch General Data Protection Regulation (Algemene Verordening Gegevensbescherming). The purpose of this privacy statement is to inform you how we use and process any personal details obtained by NABC when you visit NABC website.

Personal details

NABC processes the personal details within the meaning of Article 1, section a, of the General Data Protection Regulation. NABC uses your name address, telephone number and e-mail address in order to contact you if your personal details are used, or if NABC has questions about a report you may have made regarding a data leak on the part of NABC. Personal details that we have collected from you may be stored and processed in the Netherlands or any other country within the European Union. In exceptional situations, data may be processed in a country outside the European Union. We only permit this if the legally required security and privacy measures have been taken.

Contact by mail

We roughly distinguish two types of automated email: transactional email that you have initiated/requested yourself, and recruiting email. Transactional email is an essential part of a service that you have chosen, such as resetting a password or confirming an application or a request for information. You, therefore, cannot unsubscribe for this type of email. If you have consented to receiving emails such as newsletters or invitations to events, you may withdraw your consent. This type of email has opt-out options. **Kindly note that once registering for an event, you give us permission to send follow-up information or information that we believe would be interesting to you. At any time, you may request for your data to be removed from our contact list.** Just as for the websites, the NABC uses analysis tools to analyze the reading and clicking behavior for newsletters in order to analyze and improve our newsletters. Linking this information to your personal details enables us to send you more relevant email communications or interest-related information.

Responsible Party

NABC is the responsible party within the meaning of the General Data Protection Regulation. This means that NABC decides which personal details are processed, as well as the purpose for which and how they are processed. NABC is responsible for ensuring your personal details are processed correctly and carefully in accordance the General Data Protection Regulation.

Purpose of the processing of personal data

NABC processes personal details in order to undertake its legal and administrative duties and to carry out other tasks belonging to its purpose . A visitor will be informed how NABC processes these personal details, and the purpose of which NABC is using or will use the personal details.

Protection of personal details

NABC ensures that personal details are encrypted when they are being sent, and that they are sent via secure connection.

Retention period of personal details.

NABC does not retain personal details for any longer than necessary for the purposes for which they are processed.

Register

As the responsible party, NABC maintains a register of all the processing activities which fall within NABC's domain of responsibility .

Your privacy rights.

You are entitled to access your personal details, and also have the right to request these details are corrected or deleted. If NABC processed your personal details, you are entitled to inspect them. If you would like to exercise this right, please contact Legal Affairs: info@nabc.nl
